Freshman Seminar is a required course for all freshman students at Grandview Heights High School beginning with the class of 2019. College and Career Readiness skills will be continually integrated throughout this course while students learn study strategies, executive functioning skills (organization), and are provided with academic, social, and emotional supports. This class will explore guiding questions that are built from an understanding of what their passions, strengths, abilities, and aspirations are. Students will learn how to align high school coursework with their college and career aspirations.

Amendment to Board Policy - Entrance Age (Mandatory Kindergarten) Second Reading
 Recommend the board adopt the following policy regarding the mandatory kindergarten entrance age:

Each child who is five years of age on or before August 1 is eligible to enroll in kindergarten. Each child who is six years of age on or before August 1 and who has successfully completed kindergarten is eligible to enroll in the first grade.

The District policy requiring successful completion of kindergarten may, upon parental request to the pupil personnel services committee, be waived provided the child demonstrates to the satisfaction of the committee the social, emotional and cognitive skills necessary for first grade, and that the child is at least six years of age by the District admittance date. This committee shall be comprised as set forth in the Ohio Revised Code.
