## **Facilities Discussion:**

- 80-90 years ago the people of Grandview invested in school buildings and infrastructure; it's our turn now.
- This is much bigger than us and will last decades longer than us.
- We discussed the importance of the PROCESS we are committing to, with NO pre-determined outcomes, and the value of community involvement throughout.

#### **Current Bond Levy**

- Original ask: 5.52 mils for \$10 million in 1995
- 2015 3.15 mills ==> \$960,844
- 2016 2.9 mills (projected)
- 2017 2.8 mills (projected)
- 2018 2.7 mills (projected)
- 2019 2.6 mills (projected) → final payment in 2019
- Maximum indebtedness (ceiling) for our district ~\$48 million
- Available indebtedness for our district ~\$45 million

## **Reviewed K-12 Facility Audit**

- the cost of maintaining current facilities is far greater than current PI dollars sobering
- does not include ADA compliance (Andy to ask to add this to report since we'd need to do this to current facilities)
- does not include any Green upgrades/efficiencies
- "can has been kicked down the road" regarding PI priorities

## Reviewed "take-aways" from Mariemont/Wyoming site visits

- Lighting, flooring, ceiling, windows and paint can do a LOT
- Don't go cheap on flooring
- PROCESS is key!!
- · Maintain historic integrity of buildings
- Common spaces, Interior glass
- Like Mariemont over Wyoming; Mariemont felt do-able!
- Feeling of MORAL IMPERATIVE to do something;
- · Added bonus: retention of leadership team; rejuvenation of teaching staff

Reviewed Draft Timeline; discussed bond AND small operating levy as possibility in Nov 2017
