# Superintendent's Report

# **Teaching and Learning**

- State Report Card Update: Two important facts to share are that we had the highest graduation rate in central Ohio as well as the highest Performance Index in central Ohio for the third year in a row.
- Twelve (12) Grandview Heights Schools' teachers and principals recently attended the Dublin Literacy Conference finding new knowledge and resources to bring back to our schools.

- The final session of the 4Cs Institute is March 10. The work that principals, teachers, and the 21st-century team have done with the Institute has led to implementation project-based learning with several grade levels.
- Edison Intermediate will be extending the instruction day for students in 2016-2017 increasing time to focus on core academics and related arts classes, increase availability of enrichment opportunities, and offer a longer lunch and recess.
- EILMS hosted a Parent Curriculum Night on March 9, 2016, for rising 7<sup>th</sup> and 8<sup>th</sup> graders.
- Author Julia Cook visited Stevenson Elementary and Edison Intermediate on March 11, 2016, to share her stories that focus on social/emotional health, bullying, and resiliency.
- Principal Ken Chaffin was one of 1,300 principals nationwide who participated in the first national Shadow a Student Challenge. This event was created to offer principals an opportunity to gain understanding and empathy for their school's users. - In celebrating teaching and learning beyond the classroom, please join me in congratulating the following:
  - Congratulations to the staff and students who brought us *Meet Me in St. Louis*. They all did a fantastic job.
  - Nya Feinstein and Charlotte Gross participated in the Tri Village Rotary 4-Way speech competition. Nya placed first and will move on competition and Charlotte placed third overall.
  - Jackson Furbee and Georgia Mattingly were recently awarded Northwest Kiwanis \$1,500 college scholarships.
  - Eryn Wolfe is one of only 12 Central Ohio Outstanding Zonta Club Award recipients.
  - Wrestling Team Brendan Fitzgerald, Benton Bair, and Hudson Jump qualified for State. Brendan placed 2<sup>nd</sup> (138 lbs), Hudson Jump placed 7<sup>th</sup> (182 lbs). Hudson is the first GHHS freshman to place at States and take the podium.
  - Basketball Team Boys Varsity Basketball won the District Title against third seed Centerburg (43-40), but then were defeated in the Regional Semi-Final by St. Bernard Roger Bacon on March 9 (58-83).
  - Swimming Adrienne Bechtel, Mary Emma MacLeod, Martina Moncolova, and Keelin O'Connor qualified for the 2016 State Meet. Adrienne Bechtel qualified for the 50 Free and is the first female swimmer *ever* to qualify for States in an individual event. The four together competed in the 400 Free Relay. Calvin Furbee qualified for States in both the 100M Butterfly (placed 15<sup>th</sup>) and the 200M Freestyle (placed 10<sup>th</sup>).
  - The Grandview Singers earned straight superior ratings at OMEA District Adjudicated Events from all four judges. The Grandview Singers has advanced to the state level for the 12<sup>th</sup> year in a row.
  - Grandview Heights Schools' Science Olympiad team placed second at the Regional Tournament held here on Saturday, March 12. Team members will advance to State competition on April 9.
  - James Shannon received an Honorable Mention writing award sponsored by the Arnold Fencing Classic and Columbus Rotary for his essay "The Courage of Fencing" regarding the courage it takes to compete in the sport as an athlete with autism. Arnold himself stepped into the fencing ring to present James with his award.
  - Extended Learning Core students recently competed in The Stock Market Game with teams from other districts. The 10-week curriculum involves math, social studies, and language arts while also allowing students the opportunities to trade and learn.
  - FIRST Robotics competed in the Pittsburgh Regional Competition last weekend and experienced tremendous success. They will be competing at Xavier University March 31-April 2.
  - Larson Middle School Power of the Pen Team has five students who have qualified for the State competition.

- Transitions Coordinator Chris France has been named the Transitions Coordinator of the Year for the State of Ohio.
- Counselors, psychologists, administrators, and a Syntero representative met with community members on February 25, 2016, to continue the inclusivity discussion.
- Team members are invited to be presenters at the Batten Conference, July 14-17, in St. Louis, MO, to share the journey of welcoming students with Batten Disease into our school community.
- The district's health insurance committee has begun the cost savings discussions of moving to a consortium.
- Kevin Harrison of HPG/Harrison Planning Group has been in our district for several days assessing our facilities.
- On March 18, leadership team members will visit the PAST Foundation.
