#### Superintendent's Report

• Teaching and Learning

Grandview Heights High School has once again been named to the AP District Honor Roll by College Board and is the only school in Ohio to receive the award two years in a row. The 8<sup>th</sup> Annual AP Honor Roll consists of 447 school districts (approximately 29,000 schools) in the U.S. and Canada that simultaneously achieved increases in access to Advanced Placement courses for a broader number of students and also maintained or improved the rate at which their AP students earned scores of 3 or higher on an AP exam.

The second-grade team is working with the Growing Together Network to design and plan a service-learning project which will support the Senior Center in Grandview Heights. This unit will integrate many social standards and will focus on the Learning Attribute of empathy.

The fifth-grade team read together the novel *Wonder* and viewed the film version at the Grandview Theater. Students have since worked on connecting lessons to kindness. They have created their own precepts (life lessons) that connect to the book. The Student Services Department was pleased to have 60+ parents/adults attend a showing of the movie, *Wonder*, which was followed by a brief discussion of the themes in the book.

Congratulations to our Performing Arts Department for an amazing month of vocal music, band, and string concerts. We also had Stevenson Elementary students present a guitar recital.

Grandview Heights is in third place in the MSL-Ohio all-sports standings, just one point behind second place Bexley. Grandview Heights had 100 student-athletes named Academic All League (meaning earned a Varsity Letter and a 3.5 cumulative GPA). Grandview led the MSL-Ohio in this category. And congratulations to Wes Ryan who was named to the United Soccer Coaches Association's All America Team.

#### • District Wide

Grandview Heights Schools earned the *Auditor of State Award* for the fiscal year ending 2017 audit. This is the third year in a row that the district has received this recognition. Kudos to Treasurer/CFO Beth Collier and Assistant Treasurer Jennie Clifton.

During the December 7 late start, the Grandview Heights Staff participated in professional development directed by Chief Academic Officer Dr. Jamie Lusher.
